

Contest and Promotion Rules for Corrosion Materials

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE OR PAYMENT WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED.

PROMOTION PERIOD: Monday, March 29, 2021 – Sunday, April 11, 2021

HOW TO ENTER:

- Online: Every Order placed on our website (<https://portal.corrosionmaterials.com>) within the Promotion Period will grant one (1) entry to the Promotion.
- Off-line: Download your contest entry form at corrosionmaterials.com/promotions/entry_form.pdf. Please print, fill out and mail your entry in a self-addressed, stamped envelope to Corrosion Materials Attn: Promotions, 2262 Groom Rd., Baker, Louisiana 70714 to be granted one (1) entry per submission. Submissions must be received by Corrosion Materials no later than Friday, April 9, 2021.

Unless otherwise specified by Corrosion Materials (the “Company”), these rules cover routine contests and promotions conducted by the Company. These rules may be amended by separate specific rules for major contests or promotions conducted by the Company or its sponsors.

The contest promotion (the “Promotion”) will take place during the dates and times specified in the official rules of the Promotion (the “Promotion Period”) or as announced via email. The Company may change the dates and/or terms of the Promotion without prior notice. Any material changes will be posted on the Company’s website located at corrosionmaterials.com.

To be eligible to enter or participate in the Promotion, participants must follow the instructions set forth in the official rules of the Promotion or as announced on-air and must fulfill all of the eligibility requirements of the Promotion. Unless otherwise specified, the Promotion is open to all participants of the Company who are legal U.S. residents, 18 years of age or older.

Employees of the Company, its licensee, the licensee’s parent, subsidiary and affiliated entities, Company’s advertising and promotional agencies, and the members of their immediate families and/or households are ineligible to participate or win. Participants are eligible to win a prize in a Promotion conducted by the Company only once every sixty (60) days. Only one winner per household is permitted in any Company-conducted Promotion. Entrants are required to provide truthful information and the Company will reject and delete any entry that it discovers to be false or fraudulent. The Company will disqualify any entry from individuals who do not meet the eligibility requirements, and the Company will also delete any online entry knowingly received from persons under the age of 13 in compliance with the Children’s Online Privacy Protection Act.

Promotion prizes and their values will be indicated when the Company announces the Promotion. Unless otherwise announced, all prizes will be shipped to the winners or may be picked up at the offices of the Company at 2262 Groom Rd., Baker, Louisiana 70714.

Prizes may be claimed during regular business hours (between 8:00 am and 5:00 pm, Monday through Friday). Promotion winner(s) will be required to present valid government-issued photo identification and provide their complete address, date of birth, and phone number to claim a prize. Unless otherwise permitted by the Company, winner(s) must claim his or her prize in person, and a prize cannot be claimed by third parties on behalf of the winner. If a Promotion is open to entrants under the age of 18 and a winner is under the age of 18, a parent or legal guardian must claim the prize. Failure to comply with these requirements will result in the forfeiture of the prize. A winner will forfeit any prize or prize certificate not claimed within thirty (30) days (or sooner for time-sensitive prizes) of winning. Unless otherwise specified or required by law, if a prize is not claimed no alternate winner will be selected and the prize will become the property of the Company. The Company, solely at its discretion and only with the consent of the winner, may opt to deliver the prize to the winner by mail or overnight courier.

In such an event, the winner assumes the risk of the prize's loss, and the Company will not be responsible for the safe arrival of the prize or prize certificate. There is no substitution, transfer, or cash equivalent for prizes, except that the Company may, at its sole discretion, substitute prizes of comparable value or cash. Each prize is expressly limited to the item(s) announced by the Company and does not include taxes, gratuities, or any other expenses. Other restrictions may apply.

Decisions of the Company's management with respect to the Promotion are final.

Potential winner(s) will be selected Monday, April 12, 2021 and notified of their prize in the manner announced by the Company. If a potential winner cannot be contacted within the required time period of thirty (30) days, or if a prize or prize notification is returned as undeliverable, the potential winner forfeits the prize. The Company may change the drawing date of the Promotion without prior notice.

Prior to awarding any prize or prize certificate, the Company in its sole discretion may require the winner of such prize (and his or her travel companion(s), if any) to sign a liability release, which holds harmless the Company, its licensee, its parent, subsidiary, and affiliated entities, their respective officers, shareholders, directors, employees, agents and representatives and all of their successors and assigns against any and all claims or liability arising directly or indirectly from the prize or participation in the Promotion. The Company is not responsible for (i) lost, stolen, mangled, misdirected, postage due, illegible, incomplete or late entries; (ii) telephone or mobile service outages, delays, busy signals, facsimile transmission errors, equipment malfunctions and any other technological difficulties that may prevent an individual from completing his/her telephone call or from sending a text message (if applicable, message and data rates may apply, and the Company is not responsible for any fees incurred by an entrant for this method of entry); or (iii) entries not received due to difficulty accessing the internet, service outage or delays, computer difficulties or other technical difficulties.

Company reserves the right to cancel, terminate or modify the Promotion as it deems necessary if it is not capable of completion as planned, including, without limitation, as a result of infection by computer virus, bugs, tampering, unauthorized intervention or technical failures of any sort. The Company reserves the right to make changes in the rules of the Promotion, including, without limitation, the substitution of a prize or equivalent value, which will become effective upon announcement. If due to circumstances beyond the control of the Company, any event related to the Promotion or prize is delayed, rescheduled, postponed, canceled or has a change of venue, the Company reserves the right, but is not obligated, to cancel or modify the Promotion and shall not be required to award a substitute prize. The Company is not responsible for typographical or other errors in the printing, the offering or the administration of the Promotion, or in the announcement of a prize.

The Company, in its sole discretion, reserves the right to disqualify any person tampering with the entry process or the operation of the Company's website. Failure to comply with the rules of the Promotion may result in a contestant's disqualification and/or forfeiture of any prize or prizes. If the Company makes a good faith determination that an entrant has cheated or committed fraudulent activity in connection with a Promotion, the Company reserves the right to disqualify that entrant from entering and/or winning future Promotions.
